The use of people refers to the use of prostitution of other individuals or other forms of sexual use of them, forced labor or services, habits similar to slavery or slavery, masculine status or the isolation of human organs or tissues;
- a person engaged in human trafficking is an individual or legal entity that commits any action related to human trafficking, independently or within a group of individuals, as well as an official who promotes human trafficking by his actions, as well as although, according to his own career powers, is obliged to hinder and fight against trafficking, which does not hinder or counter The fight against human trafficking is based on the following basic principles:
- \* legality;

- \* inevitability of responsibility of persons engaged in human trafficking;
- \* prevent discrimination of victims of human trafficking;
- \* social cooperation.

Human trafficking often occurs illegally due to going to foreign countries and engaging in labor activities. As a result of Nolegal labor migration, such unpleasant situations as the illegal crossing of the state border, gross violation of Customs and tax legislation occur.Criminals, organized criminal groups take advantage of the naivety, gullibility and insufficient information of their compatriots, condemning them into slavery.
