However, over the past quarter of a century, serious changes have taken place in the interpretation of this concept.

In January 2001, under the auspices of the UN, a commission on human security was established, which proclaimed an integrated approach to human security and called on the international community to rethink ideas about national security by moving away from traditional, state-oriented concepts of security, primarily on the security of states from military aggression, to one that focuses on people's security, protection and empowerment. The Commission on Human Security identified seven key components of Human security: economic, food, medical, environmental, personal, public and political security - and the corresponding threats presented in table.1.

A similar interpretation of economic security is given by the International Red Cross, which defines economic security as the ability of individuals, households or communities to meet their basic needs in a sustainable and dignified manner.

DATA AND METHODOLOGY

A significant contribution to the development of the concept of economic security of the individual was made by the International Labor Organization (ILO), generalizing theoretical approaches to the study of the problems of economic security of the individual in the course of the research program on socio-economic security. ILO experts proceed from the fact that economic security is closely related to labor activity, they distinguish seven components of the individual's economic security, one way or another related to a person's position in the field of employment: income security, labor market security, employment security, labor protection, guarantees of obtaining qualifications, work process security, representation security. The report also contains an analysis of the role of informal employment in the formation of the main threats and, on the contrary, protective mechanisms of the individual's economic security.

The issues of economic security of the individual were further developed in the concept of decent work (decent work), formulated by the ILO in 2013. According to it, decent work involves the creation of an environment that ensures economic security, thanks to which an increasing number of people will be able to realize themselves in the professional sphere and improve their personal social and economic security.



The approach of international organizations to the issues of economic security of the individual as a problem of ensuring the basic needs of a person is also reflected in foreign scientific literature. In many foreign studies, the economic security of the individual is interpreted in a similar way, namely, as the absence of an acute threat to the minimum acceptable level of satisfaction of basic needs, the stability of the income received by the individual, sufficient to maintain certain standards of consumption.

RESULT

To identify subjective ideas about the main elements of the economic security of the individual, a study conducted among students of higher educational institutions, as a result of which it was found that the main elements of the economic security of the individual, according to young people, are: financial security; availability of work, including the possibility of employment itself; availability of certain benefits (own housing, personal car, washing machine, computer, etc.); predictable and stable economic situation; the possibility of obtaining professional education; confidence in your future; guarantees from the state (employment, security, stability); knowledge of the economic issues of the functioning of modern society (credit, investment, risks, etc.). "On the question of who should ensure the economic security of the individual, the respondents put the state in the first place, the individual himself in the second place, then comes the enterprise where the person works, and the last place is occupied by the family in which the person lives. The state is also assigned a leading position in the possibilities of ensuring the economic security of an individual.

Under normal market conditions, the interests of subjects competing with each other at the level of state and international relations come into conflict. This means that it is impossible to achieve absolute, complete, final economic security by different subjects in parallel, because an increase in the economic security of one of the subjects means an increase in resources "on its side". income, strengthening the position in the economy and society. It should be noted that the fulfillment of interests is the result of protective measures against any threats, in other words, the unity of circumstances and factors representing possible harm.
