INTRODUCTION

In today's era of globalization, new threats and dangers are emerging, methods and means of committing crimes, and goals are changing. Taking this into account, a number of measures have been implemented in our country in recent years. "As a result of the measures taken, confidence in justice and the rule of law is emerging among our citizens. But no one has the right to be complacent, we still have a lot of work to do."¹. In this sense, it can be said that along with the achieved achievements, there are still important issues that are waiting to be solved in terms of increasing efficiency.

LITERATURE ANALYSIS

Ensuring the safety of citizens in all countries is one of the important issues, and the management of the structural units engaged in this task is carried out through various ways and methods. Each country has its own experience in this area, and their study and implementation in the system of ensuring public order and security in our country is one of the urgent issues today. Legal scholar D.V. As Vasiliev noted, the study of foreign experience makes it possible to determine the important directions of the development of society, to prevent mistakes and wrong approaches in the process of long historical development of mankind. In addition, N.G. As Khijnyakov rightly pointed out, it is necessary to take into account the specific characteristics of each country when carefully studying and implementing the experience of foreign countries.

Some aspects of the management of internal affairs bodies, inspectors on women's issues have been studied to a certain extent in the scientific research conducted by legal scholars of our country. In particular, issues related to the management of internal affairs bodies H.R. Alimov, B.E. Kasimov, O'.Kh. Mukhamedov, I. Ismailov, H.T. Odilkoriev, Yu.S. Pulatov, Z.R. Roziev, U.T. Tadjikhanov, A.S. Tursunov, I.A. Khamedov, O.T. It was studied by legal scholars like Husanov.

Directly, the organizational and legal basis of managing the activities of inspectors on women's issues, their cooperation with other subjects (I. Ismailov, M.Z. Ziyodullaev), their participation in the prevention of offenses and crimes (J.S. Mukhtorov), the controllicensing system some issues related to its role in providing (S.M. Selimanova), some aspects of citizens' cooperation with self-governing bodies (Z.R. Roziev), participation in crime prevention among unorganized youth (Sh.R. Gafurov) were researched.

RESULTS

The results of the research are as follows: A number of scientists emphasize that the organizational structure, functions and distribution of powers of foreign police bodies between different levels depends on the existing forms of government in each country and the degree of centralization of the state."While one of the important factors in ensuring the safety of our citizens is the prevention of crimes and offenses in the streets and public places, today the work of inspectors on

women's issues cannot be said to be at the level of demand."². After all, it is necessary to eliminate the problems and deficiencies arising in the management of the activities of inspectors on women's issues, which are considered to be the central subject of public order and safety, and to develop recommendations aimed at further enriching its scientific and theoretical foundations.

DISCUSSION

Based on the above views, it can be said that the problems of further increasing the effectiveness of the management of inspectors on women's issues are directly related to the legal, organizational-tactical, material-technical and personnel bases of the analyzed field. In our opinion, solving the problems and shortcomings arising in these four areas will have a positive effect on increasing the efficiency of the activity. In this regard, 33.0% of those who participated in the survey said that it is necessary to implement measures on legal provision of the industry, 16.5% on organizational and methodical provision, 41.8% on material and technical provision, and 8.7% on personnel provision. calculated.

Activities of inspectors of internal affairs bodies on women's issuesproblems related to the legal basis of management are one of the most important issues in terms of improving the industry. After all, effective management of this field requires regular analysis and monitoring of the legal frameworks that regulate it, monitoring their compatibility and implementation with social life.³.

1. As mentioned above, studies and analyzes show that today the laws that are considered the legal basis of the activities of inspectors on women's issues of internal affairs bodies are limited to the regulation of certain socio-legal relations in this regard, without serving to directly regulate this activity. and the decisions of the Cabinet of Ministers define the general rules, main directions and tasks of this activity, as well as the legal status of the subjects.

In the course of our research, when the experts were asked the question: "Do you think that the law and sublaw normative legal documents that serve to organize the activities of inspectors on women's issues of the Internal Affairs bodies are sufficient?", most of them (50.4%) said: "This of the Ministry of Internal Affairs The fact that they answered that the orders and instructions in the field are sufficient, but the higher normative legal documents, in particular laws, are not sufficient is proof of our opinion. This requires improvement of the legal basis of this activity. After all, the improvement of management is inextricably linked with the level of improvement of legislation in the environment in which it operates.

In our opinion, the activities of inspectors of internal affairs bodies on women's issueshheQheQit is desirable to improve the foundations of the house.

In order to eliminate such problems and conflicts, the inspectors of women's issues of the Internal Affairs bodies, which are considered one of the priorities in the field of socio-legal control over crime, regulate their activities in this field, including the implementation of cooperation between them. it is appropriate to develop and adopt a single draft Law of the Republic of Uzbekistan, which defines the methods, forms and mechanism.

The main goal of this law is to effectively organize the activities of preventive inspectors on women's issues of internal affairs bodies in the regulation of social relations in the field of maintaining public order and ensuring the safety of citizens: firstly, "inspector on women's issues", "women's protection" to give legal definitions to basic concepts such as "personal security"; secondly, to clearly define the scope of the entities that directly implement and participate in the activities and their powers in the cases of cases committed by women or harmful to them; thirdly, it is necessary to legally regulate the mechanisms for organizing the activities of preventive inspectors on women's issues of internal affairs bodies in ordinary and special conditions.

2. In the process of analysis and monitoring of departmental regulatory legal documents regulating the management of the activities of preventive inspectors on women's issues by the internal affairs bodies, collisions, conflicts and shortcomings related to the requirements for their content and the legal regulation of the best practices introduced in the field today are highlighted. . In particular, first of all, the following shortcomings are highlighted in terms of the requirements for their content in the departmental normative legal documents regulating the field; secondly, in some regions, preventive inspectors on women's issues of Internal Affairs bodies are not provided with service cars. Studies and research in this regard show that the new advanced work methods in the field are not legally determined by the departmental regulatory documents of the Ministry of Internal Affairs; thirdly, in the actual procedure of selecting candidates for the training of qualified specialist personnel for the positions of preventive inspectors of internal affairs bodies on women's issues in MIA educational institutions, employees who have worked in this field for many years, who have shown themselves positively, who are winners of international and national science olympiads in the relevant specialty, the issues of giving benefits to candidates awarded with state awards were neglected. This requires the internal affairs bodies to introduce appropriate changes and additions to some departmental regulatory legal documents regulating the activities of preventive inspectors on women's issues.

Taking into account the above-mentioned shortcomings and conflicts, as well as the reforms implemented in the field in recent years, the Internal Affairs bodies are trying to redevelop the departmental normative legal documents, which play an important role in the legal regulation of the activities of preventive inspectors on women's issues, in accordance with the requirements of the times. In this regard, 82.4% of the experts who participated in the survey emphasized the need to adapt the current departmental normative legal documents to the requirements of the time.

CONCLUSION

Ending crime among women is a pressing issue in any country and any society. Inspectors of internal affairs bodies on women's issues are a component of management in the IIO system. Through it, IIO enters into organizational and legal relations with state management bodies, public associations and citizens. To study, analyze and develop recommendations for the improvement of the problems related to the organizational-tactical basis of the management of preventive inspectors on women's issues of internal affairs bodies, to introduce modern information and communication technologies to the organizational-tactical management activities of the field, women's issues of internal affairs bodies is a necessary condition for effective management of prevention inspectors. Because today, in order to increase the effectiveness of IIO activities, we should pay special attention to the task of wide application of new working methods and mechanisms, in particular, digital technologies, to practical activities, having studied in depth the advanced experience of developed foreign countries.4.

The activities of preventive inspectors of internal affairs bodies on women's issuesproblems and shortcomings related to the organizational and tactical foundations of management are visible in the subordinates. In particular, firstly, Preventive inspectors of internal affairs bodies on women's issuesit can be seen that there is no methodical provision system for activity through social networks during service. In this regard, 25.1% of experts participating in the survey are provided with the necessary methodological manuals and recommendations only when there are special instructions and requirements, only 32.4% stated that they are not provided with the necessary methodological manuals and recommendations; fourthly, The activities of preventive inspectors of internal affairs bodies on women's issuesthat the issue of taking public opinion into account in the evaluation criterion was neglected, as well as the insufficient level of work on their wide distribution to other regions.

Based on the above, The activities of preventive inspectors of internal affairs bodies on women's issuesthe following can be indicated as directions for improving the organizational and tactical foundations of management.
