According to the Academy of economic security of the Ministry of internal affairs of Russia, at the end of 2015, the level of criminalization of the economy in the country was in a very "crisis" state and reached the level of 40 percent of the gross domestic product (GDP) of the economy, in 1991-there or 11 percent.

According to the 2017-th year of the Anti-Corruption Research Center Transparency Int (TI), the index of the appropriation of the state of corruption in Russia was 2,3 points, falling to 143 — the place in 180 states-Gambia, Indonesia and Togo...

The above-mentioned International Organization has published its 2018 corruption Acceptance Index. According to the 100-point index, Uzbekistan received 23 points, ranked 158th in the overall rating among 180 countries and territories. This rating is calculated on the scale from 0 (very high level of perception of corruption) to 100 (very low).

The index of perception of corruption — the level of corruption in the public sector is assessed by experts and business representatives. As in previous years, the average score of more than two-thirds of the countries of the world stands at an indicator from 43 to 50. According to the developers of the index, this is evidenced by the fact that most countries-could not seriously control corruption and the crisis of democracy.



Denmark took the lead back from New Zealand with 88 "points". Strong decimals entered Finland, Singapore, Sweden and Switzerland (85 points each), Norway (84), the Netherlands (82), Canada and Luxembourg (81 points). The worst indicator is in Somalia (10), Syria, South Sudan (13), Yemen and North Korea (14).

"Our research has shown a clear link between healthy democracy and the fight against corruption in the public sector," said Delia Ferreira Rubio, chairman of the International Organization.

In 2018, Estonia ranked 18th in the countries of the former USSR on the corruption awareness index, Georgia-41, Belarus-70, Kazakhstan — 124, Tajikistan — 152, Uzbekistan — 158.

RESULTS AND DISCUSSIONS:

The Anti-Corruption Agency, established in accordance with the decree of the president of the Republic of Uzbekistan "on additional measures to improve the Anti-Corruption System in the Republic of Uzbekistan" on June 29, 2020, along with the formation and implementation of the state policy in this regard, should work hard to improve this indicator.

We believe that this should be given importance to one factor, that is, the legality of the withdrawal of money when buying real estate should be checked. According to official data, it is known that the income of 10 percent of the most disadvantaged people exceeds the income of the poorest citizens in 10-15 — fold.

Many experts note that the real discrepancy in the middle is 25 — 40 times, given the "hidden economy". The poor population that is currently living below the living minimum is 15 percent. A big shake has been observed in this matter since 2019, even though a whole ministry is working, the difference in the middle can make different opinions appear in the layers of society.

We believe that the gradual introduction of the System Anti-Corruption internal of control ("complayens-control")in all state and economic management bodies in 2020-2021 will give impetus to radical changes in the sphere. In order to fulfill the requirements of the International Convention, the agency is entrusted with the duties and powers of the National Coordinator of the Republic of Uzbekistan for coordination of activities in this direction, the development of the "road map" to improve the position of our country in the international ratings, serves to further increase the status and prestige of the office.

It means that bold steps are being taken to eliminate corruption that is becoming an obstacle to national development. The main thing is that no matter how the law-enforcement agencies act in the fight against corruption, we cannot organize an effective struggle against this scourge unless our people establish impressive public control, without compromising this disgusting act.

Of course, in our country, too, drastic measures are being taken to combat this evil. Studies have shown that the most effective means of eliminating a malady is the struggle with the cause, and not with the malady itself.

The fact that corruption becomes a serious obstacle in the implementation of both political and economic reforms in our country is of concern to the



public. Therefore, the processes of democratization and modernization of the Society initiated by our compatriot continue with difficulty.
