All countries of the world have set themselves the task of realizing the rights and freedoms and legitimate interests of citizens, creating perfect legislation, ensuring its unconditional implementation, raising the legal culture of the population and officials, the rights and obligations of citizens, public authorities and administration's primary task and goal. The juridical services of government agencies and organizations, as well as business entities play an important role in this process. As a result of the reformations of the last five years, the necessary political, legal, socio-economic and scientific-educational foundations for the establishment of a new Uzbekistan have been created in our country.[1]

Over the past periods organs of government, institutions and organizations in our country have been improving. In particular, over the past 5 years comprehensive measures have been taken to protect the rights, freedoms and legitimate interests of natural persons, as well as government agencies, institutions and organizations of the country. The Action Strategy for the five priority areas of development of the Republic of Uzbekistan for 2017-2021 years: such as radically improving the quality of legal aid and legal services "[2] and of course, extensive work has been done in this area.

Speaking about legal services and jurist consult many people imagine a lawyer who works with documents just for the sake of formality. In fact, the person in this position should be a well-educated, openminded, up-to-date specialist who protects the rights of citizens and is responsible for ensuring the rule of law in the system of public authorities.

President of the Republic of Uzbekistan Shavkat Mirziyoyev has set specific tasks for us to ensure the rule of law in society. There is a need to improve the legal service, as it is an important link in achieving this goal. First of all, before defining the concept of juridical service, we should pay attention to the opinion of Professor A.P Korneev, who noted that the content of legal work, its scope, form and methods are divided into appropriate types. The main types of legal proceedings are court of justice; supervising prosecutors; criminal investigation; legal assistance to citizens and organizations (advocacy); notarial acts; legal affairs in organs of government, institutions and organizations.[3]

Defining the concept of juridical service it is an independent structural unit or position that is compulsorily established or introduced in accordance with the norms and criteria established by law in order to legally support the activities of the state body and organization.

The juridical service reports directly to the head of the state organ and organization. Legal services can be in different forms. For example, it may consist of a juridical department, a juridical management, juridical sector, a juridical bureau or it may be a unique state which inludes chief jurisconsult,a senior jurisconsult or jurisconsult.[4]

Of course, legal services in the Republic of Uzbekistan are carried out by lawyers. If we analyse the lexical meaning of the word jurist, it means "jurispritus" in Latin - "jurisprudent" or "competent in law". Linguistically, a person with legal knowledge, who

knows the law [5] and the ability to apply them in practice.

Jurisconsult is one of the legal specialties who carries out legal work in organs of government, business administration bodies, business entities institutions and organizations).

A.P. Korneev defines "Jurisconsult – as the head of the legal department (bureau) of the juridical service of public authorities, institutions (concerns, associations), socio-cultural institutions, organizations, the chief (senior) jurisconsult, an employee in the position of jurisconsult" [6] . In juridical encyclopedias it is defined as person qualified to advise on legal matters, a master of jurisprudence

Professor G.Abdumajidov emphasizes how useful it is for an institution, organization to have its own lawyer to operate it legally.[9] Juridical service in the system of the National Guard of the Republic of Uzbekistan, in turn, provides legislation in the departments, divisions, institutions, training centers of the system; to protect the rights and interests of all types of servicemen or employees in the system, even during the preliminary investigation and in court, to protect the rights of this serviceman or employees along with his lawyer; implementation of comprehensive measures aimed at preventing offenses among servicemen or employees; service inspections. It is expedient to make proposals on modernization of the norm-making process, improvement of the legislation of the Republic of Uzbekistan in order to ensure strict implementation of legislative acts.

In order to eliminate corruption in the civil service, to improve the legal framework for the recruitment of personnel on a competitive basis and to assess the effectiveness of their activities, the legal service systematically analyzes the existing regulations of the National Guard. I believe that it is expedient and that it will serve as a key to the effective implementation of these goals set by our President.

In conclusion, I would like to say that the rational organization of the juridical service system in the National Guard of the Republic of Uzbekistan, in turn, leads to the establishment of a democratic rule of law, the formation of civil society, improving national legislation, as well as serves to promote legal culture inside the society and among military personnels.
