The personality of a criminal is understood as a sane person who committed a socially dangerous act prohibited by law, brought to criminal liability and reached the age of criminal responsibility. Only the court can recognize a person as a criminal. The specific essence of the criminal's personality consists in the specifics of his mental warehouse, which expresses the internal conditions of antisocial behavior, and also determines the individual characteristics of behavior that have legal significance in connection with the legal status of the person who committed the crime. The concept of the personality of a criminal reflects the legal characteristics (indicating who can be) characterizing the subject of a crime in accordance with the law and the characteristics of its spiritual essence.

The concept of the personality of a criminal includes a whole complex of socio-demographic, socio-role (functional), socio-psychological signs, which to some extent are associated with a criminal act, characterize his social shame and explain the reasons for its commission. Such an approach, confirmed in the legal literature, encourages to supplement the concept

of a person in relation to the subject of a crime with a number of signs that are not considered in general psychology. Therefore, legal psychology-studies a wide range of personal characteristics of the person who committed the crime, paying attention not only to his moral qualities, knowledge, behavior, habits, forms of mental reflection, temperament, but also to the physical nature of the person. A person as a person, his age, mental abilities, some of his functionality are signs of a role, for example, an official position, a special obligation or a special position in relation to the victim, etc.

In criminal law, along with the term" personality of a criminal", the following phrases are used: the person who committed the crime; the subject of the crime; the person of the guilty (for example, Articles 6, 60, etc.) of the Criminal Code of the Russian Federation. Thus, the last of these phrases covers the same signs and characteristics as the personality of the criminal. In the second case, the emphasis is based on such characteristics of the personality of the subject, his behavior, which are more related to the assessment of the degree of guilt in the Act, helping to explain the reasons for the crime committed by him, being important in determining the severity of his responsibility and punishment for his act. • Thus, the personality of a criminal is a set of negative socially significant qualities that are manifested in a certain criminal act. The personal qualities of the culprit should be considered from the point of view of their hierarchical structure. And here both the general value-indicative scheme of a person and the psychological characteristics of certain categories of criminals come to the fore. The personality of the offender not only reflects certain external conditions, but is also an active side of interaction. It is characterized by conscious, purposeful activity. The connection of social conditions with criminal behavior is complex and always social conditions are manifested in a crime and are violated through a person.

Psychological study of the personality of a criminal involves the study of his inner world, needs, motives, the basis of actions, emotional-volitional abilities, individual characteristics intellectual activity (thinking, perception, memory and other cognitive processes). The study of these psychological characteristics of a criminal should be an integral part of the investigation of a crime, and in each individual case, the scope of this information should be determined depending on the category and nature of the criminal case and the personal characteristics of the accused. The psychology of the personality of a criminal must be studied so that the investigator can ensure the solution of criminal-legal, criminal-procedural, criminological and Correctional problems in a particular case. A wide range of information about a person involves the use of many sources of information about the procedural and nonprocedural psychology of the accused.
