In order to form personal and intellectual qualities in students, teachers should implement the following: be able to see each student as a separate, unique person; - respecting the student; - ability to correctly assess the student's mental state; - consideration of the student's wishes and interests; - tolerant attitude towards each student; - confidence in the student's strength, potential and aspirations; - to create a comfortable learning environment for every student; creating an opportunity for students to work independently or in small groups[15]; - teaching students to independently control their activities, to determine the effectiveness of their activities, to analyze the factors of success and the consequences of mistakes; - not to pressure any student during the educational process; - not to exaggerate the shortcomings of individual students; - if the student's inability to assimilate knowledge, indecent behavior during the education process is noted, without making a firm conclusion, to determine the reasons for this; elimination of situations such as the student's inability to absorb knowledge, indecent behavior, without harming the student's honor and pride based on the identified reasons; - to be able to create an "environment of success" for each student in the educational process; - to help every student learn and succeed; - to develop the student's abilities, to help him develop as a person. All this is done through pedagogues working in higher education[7].

Students to acquire the skills to achieve effective academic achievements, teachers, group leaders, and subject teachers should support them and guide them. additional conditions should be created for training and acquiring professional knowledge.
