Punctuation, derived from the Latin punctum, meaning dot or small point, is a system of non-alphabetic symbols that is an important component of written language, along with graphics and orthography. Its main task is to divide the text into sections and present it graphically. Punctuation also includes historical rules and norms specific to each language that govern how punctuation is formalized in written text.

Orthography studies the correct spelling of words and is closely related to morphology; punctuation is closely connected with syntax, serving for the correct expression of the thought in it, the correct structure of sentences. For example, the fact that punctuation

marks such as interrogative, exclamation, period are followed by a capital letter, and after colons and semicolons are often written with a lowercase letter is a factor that indicates the relationship between punctuation and orthography.

compare the following three similar sentences from a grammatical point of view, the role of punctuation in the expression of written language becomes very clear :

2. Was the cotton plan completed ahead of schedule?

3. The cotton plan was completed ahead of schedule. The first of these sentences is a message, the second is a question, and the third is an emotion.

Such semantic relations are expressed using intonation in oral speech; and in written speech it is shown only with the help of punctuation marks . It can be seen that the meaning (purpose) in the written text can be clearly expressed using punctuation marks. Nowadays, the role of punctuation marks is increasing, the functions and scope are expanding.

This phenomenon is the wide development of printing, printing and publishing works in our republic, the rise of Uzbek written culture, the increase of people's literacy and the ability to use all forms of speech in their practical activities, and the expansion of the influence of fiction. The emergence, development and improvement of functional styles of language and literary language is explained by the wide-scale development and rise of speech culture. Accordingly , determining the place of punctuation marks in the expression of written speech is closely related to solving the current issues of speech culture, especially written speech culture.

parts, but also the purpose of expression and the emotional side of these parts. So, the question mark, exclamation mark and periods in the text perform two main tasks: a) complete the sentence logically and grammatically; b) indicates the observable purpose and emotional states in this sentence. Although the comma in the fourth sentence also fulfills a logical-grammatical function, its function is different from the functions of question, exclamation and point: comma is different from the functions of question, exclamation and point. the previous part from the next part.

showing all the functions of using punctuation marks in written speech , we limit ourselves to highlighting their common aspects and the most common cases in the writing process. Punctuation marks serve to clearly express the content (meaning, idea) of the written text[3].

For example: "May my brother build... Shahadat!" Let it go; come on! The first sentence expresses emotion, the second sentence expresses exclamation. Punctuation marks not only express the general semantic relations specific to the whole sentence, but also have the feature of expressing the semantic relations specific to the parts of the sentence. (Proverbs) We have followed this path - we have reached our goal, our poetry has reached perfection.

The first of these conjunctions expresses a condition, the second an opposition, and the third a cause-and-effect relationship. In this case, despite the fact that the hyphen expresses different semantic relations (meanings) between the parts that make up a complex sentence , it performs one syntactic task - the task of separating one sentence from another. The use of a single punctuation mark in such different meanings is punctuation polysemy. Homonymy of punctuation marks - one punctuation mark performs different functions. Sometimes the meaning of sentences is complex.

In such cases, punctuation marks are used together: Is this a strong bond, such love ?! (F. Usman) Dividing and separating parts of sentences with punctuation marks is different. This difference is determined by syntactic relations, syntactic-stylistic situation. For example, the introductory word, exclamation and exclamation at the beginning and end of the sentence are separated by one (one) punctuation mark; and when in the middle of a sentence, it is separated by a double (two) punctuation mark: Finally, Ikees, can you imagine happiness other than honoring the people? The single and combined use of commas in the above examples does not mean that their function is different.



Although there are two types of commas (singular and compound), they serve the same purpose - to separate the introductory words from the main sentence. is used. whether a particular text uses certain words or phrases in a different sense[4].

This function is mainly implemented using parentheses and quotation marks. Punctuation marks are distinguished according to their function. For example: "Why can't you live without sleep?" Sometimes such a feeling surrounds me: "Humanity is eternal, eternal, and do not let the sleep of carelessness enter you!" (Muzaffar Turobov) As if. in modern Uzbek writing, the basis of punctuation marks performs a logical-grammatical, syntactic-stylistic function. When determining the size, position and order of punctuation marks, they are converted into syntactic rules of a given language. Each punctuation mark in the written text reflects a specific syntactic and stylistic phenomenon[5].
