The second of the action strategy in paragraph 4 of the priority direction " ... raising the legal culture and awareness of the population " [1. 4;], is considered as the main priority . In addition, President of the Republic of Uzbekistan Shavkat Mirziyoyev at the solemn ceremony dedicated to the 26th anniversary of the adoption of the Constitution of the Republic of Uzbekistan "The Constitution is our free and prosperous life, a solid foundation for the further development of our country " [2. 12;] to prepare young people for living in civil society, to develop in them an active position of social citizenship, to form a common culture .

The Decree of the President of the Republic of Uzbekistan "On radical improvement of the system of raising legal awareness and legal culture in society" criticized the lack of systematic and integrated work on raising legal culture, especially in the field of legal education. That is, " the formation of civic competencies in respect of factors that negatively

affect the legal education of young people, respect for the law and morality, loyalty to national values, intolerance of crime is not taken in a comprehensive manner" [3. 6;]. Presidential Decree "High legal culture - a guarantee of the country's development" The Concept "Raising the legal culture in society" was developed on the basis of the conceptual idea . It states: "The main goal of the Concept is to create a comprehensive system of educating all segments of the population to be legally literate, strong-willed, knowledgeable and respectful of the law, able to apply legal knowledge in everyday life, active citizenship and intolerant of crime. 3. 6;] ". This is due to the active study of the possibility of using new pedagogical technologies in the classroom in the formation of an active civic position and legal culture in higher education , the creation of new, modern forms, analysis of the peculiarities of this process, modernization and improvement . requires.

Pedagogical sources have different definitions and approaches to competence, with the following **descriptions** :

According to NMMuslimov, the English word "somretense" literally means "ability", but the term competence serves to express knowledge, skills, abilities and abilities.

NV Tarasova interprets the concept of competence as a general ability based on knowledge, values, abilities that allow to provide a link between knowledge and situation, knowledge and action to solve a problem . In our view, it can be concluded that competence is a person's ability to solve a particular problem based on existing knowledge and life



experiences. It should be noted that most of the definitions of the concept of competence are related to professional education, professional activity. However, since this concept has a description of innovation in relation to general secondary education, there is a special need to clarify its essence.

V.I. According to Andreev, competence is a developing integrated indicator, manifested in solving certain educational, professional and other complex problems, and is the level of readiness of the individual (including positive motivation, knowledge, skills, abilities and experience of creative activity).

Socially active civic competence means to be involved in the events and happenings in the state and society, to take an active part in these processes, to know one's civil rights and duties, to observe them, to demonstrate intercultural skills, to have a legal culture.

"National and intercultural competence means loyalty to the motherland, kindness to people and belief in universal and national values, understanding of works of art and art, the ability to follow cultural rules and a healthy lifestyle."

The development of civic and intercultural competencies in students is one of the most pressing issues today, because today a number of destructive groups operate in the regions of the world, creating a number of problems in the political, socio-cultural and educational life of these countries. According to the data, the number of terrorist acts is growing every year, in 2018 alone, there were 15.3 thousand terrorist attacks in the world; one person commits suicide every 40 seconds on earth, and almost one million people die each year due to suicide [4. 3;].

The large-scale reforms being carried out in our country in recent years in the social, spiritual, political and economic spheres, as well as global changes, pose a number of challenges to the state and society. The increasing flow of destructive information, the spiritual and values changing moral reauire appropriate work at the individual, group and community levels to develop the civic and cultural competencies of the citizens of the Republic of Uzbekistan . According to the decision of the Supreme Court of the Republic of Uzbekistan dated March 12, 2019, 40 Uzbek-language profiles, channels and pages on the Internet have been declared extremist and terrorist. The head of state Sh. Mirziyoyev said, "Of course, we are doing a great job in educating young people who think independently, have modern knowledge and skills, and have a strong life position. However, if we take into account the fact that today the whole world is struggling to win the hearts and

minds of the population, especially young people, and the threats of religious extremism, terrorism, drug addiction, "popular culture" are growing, the upbringing of our children we must not weaken our work in the field of enlightenment for a moment, but raise it to a new level [5. 17;] "and outlined the tasks to be performed in the development of civic and intercultural competencies in students.
